Ramachandran-National Bioscience Award (NBACD-2019) of Dr. Naveen C. Bisht, Scientist, NIPGR.

Field Worker (one post): Emoluments ` 18000/- plus HRA per month and as per DST norms.

Upper Age Limit: 50 years.

Qualification: Candidates having Graduate Degree in any discipline are eligible to apply. Candidate having three years of working experience in field related work including growing and maintaining crop plants will be preferred. Candidate having prior experience in research labs and working with Brassica crops and Arabidopsis will be given preference.
