Name of Position: Project Associate-I (PA-I) 01 post. - Upper age limit for PA-I: 35 years.

Qualification: Candidates having Master's degree in any branch of Biological/Life Sciences with at least 60% (or equivalent) marks or an equivalent degree in any branch of Biological/Life Sciences as mentioned in the DST Office Memorandum number SR/S9/Z-07/2020 dated 25/08/2020 with at least 60% (or equivalent) marks are eligible to apply. Furthermore, candidates with experience of hands-on working (either during or after the Master's degree) with some of the techniques such as PCR, CRISPR-Cas9, analysis of genome-edited plants, handling of rice plants will be given preference.

The successful candidate is expected to work on analyzing genome-edited rice lines and their molecular, metabolic and phenotypic characterization.

The Fellowship amount for the above position is at par with the similar fellowships by DBT/DST. The above position is completely on temporary basis with a maximum duration of three years. The initial appointment will be for a period of one year, which can be curtailed or extended based on the performance of the candidate and discretion of the Competent Authority. BRIC-NIPGR reserves the right to select the candidate against the above post depending upon the qualifications and experience of the candidate. Reservation of posts shall be as per Govt. of India norms. The position may be terminated any time by giving a month notice by either side. The applicants will have no claim implicit or explicit for consideration against any regular position of BRIC-NIPGR.
