Applications are invited from suitable candidates for filling up the purely temporary positions in the DBT project entitled "Plant Genomics, Gene Regulatory Network and Novel RNA Molecules under "Establishment of Bioinformatics and Computational Biology Centre (BIC) in New Delhi under the supervision of Dr. Shailesh Kumar, Scientist, NIPGR. The details of positions are as under:

Project Associate-II (one post): Emoluments ₹. 28000/- plus 27% HRA per month, as sanctioned in the project.

Qualification: Candidates having Master's Degree (with a minimum of 60% marks or equivalent CGPA) in Bioinformatics or Natural Science or Agricultural Sciences and having two year of research experience and fulfilling the guidelines as per DST-OM number SR/S9/Z-05/2019 dated July 10, 2020 are eligible to apply. **The upper age limit of the post is 35 years.**

Scientific Administrative Assistant (one Post): Emoluments ₹. 18000/- plus 27% HRA as sanctioned in the project.

Qualification: Candidates having a Graduate degree in any discipline with at least 60% marks and fulfilling the guidelines as per DST-OM number SR/S9/Z-05/2019 dated July 10, 2020 are eligible to apply. Candidates having prior experience in day-to-day general administrative and financial management-related work in any research laboratories/institutions will be given preference. Basic computer literacy with knowledge in MS Office tools is desirable. **The upper age limit of the post is 35 years.**

The above positions are completely temporary and co-terminus with the project. The fellowship amount for the above positions is as sanctioned in the project and as per DBT/DST norms. The appointment will be valid till the tenability of the project i.e. up to December 17, 2025 the same can be curtailed based on assessment of the candidate's performance and discretion of the Competent Authority. NIPGR reserves the right to select the candidate against the above post depending upon the qualifications and experience of the candidate. Reservation of posts shall be as per Govt. of India norms. The appointment may be terminated at any time by giving one-month notice by either side. The applicants will have no claim implicit or explicit for consideration against any regular position of NIPGR.
