- 3. The contractor shall arrange all T&P and nothing extra will be paid.
- 4. The contractor must get the prior approval of Good earth & cow dung from the Engineer- In -Charge.
- 5. The rates shall be inclusive of Transportation, loading, unloading and handling charges of material.
- 6. The rates will be for finished items inclusive of the cost of material & Labour complete.
- 7. The rates shall be inclusive of all taxes including VAT & Service tax.
- 8. The contractor shall follow all labour laws as prevailing in Delhi.
