Sealed Tenders are invited on behalf of Director, NIPGR from the Original Equipment Manufacturer or their authorized dealers for the purchase of **01 no. of Laminar Flow Bench** for the laboratory of our Institute, as per the following specifications in two bid system.

## **Technical Specifications**

- Horizontal Laminar flow Bench with stainless steel Table top.

- Size of the Laminar flow Bench must be 2'X 2'X 2'

- It must contain UV light, Polycarbonate Door, Gas cock and manometer.

- The bench need to be made of thick ply board and must be reinforced with teak wood.

- All visible surfaces must be laminated.

- All interior surfaces must be painted with air drying epoxy paint.

- The filter seat must be rubber padded.

Sheet duly framed must be made with anodized aluminum frame and work table must be made with of stainless steel table top.

- At suction end the unit must be provided with washable pre-filters. The Pre-filter must have an efficiency of 90% down to 10-micron particle size. The Pre-filters must be provided with expanded metal covers for protection.

- The unit should contain with super air H.E.P.A. Filters comprising of Non –woven microfibres. The efficiency of the filter need to be better than 99.97% down to 0.3-micron particle size.

- The blower assembly must be consisting of ¼ H.P. electric motor of G.E. Make and balanced blowers.

- The entire blower assemble need to be mounted on frame and suspended on "S" hooks allows the assembly that no noise or vibrations are generated.

- The unit must be illuminated by fluorescent tubes light and is designed provides a work area, confirming to class-100 of revised US-Federal standards 209-S.

You are therefore requested to please send your offer in **two bid system** indicating the maximum discount offered, installation charges along with a copy of authorization certificate, issued by the Principals/OEM.
