Sealed Tenders are invited on behalf of Director, NIPGR from the Original Equipment Manufacturer or their authorized dealers for the purchase of **01 no. of Stereozoom Microscope** for the laboratory of our Institute, as per the following specifications in two bid system.

Technical Specifications

- 1. Apochromatically corrected stereozoom microscope with at least 9:1 zoom ratio, and with integrated camera.
- 2. Magnification range: 6.1 to 55x with 1x objective & 10x eyepiece.
- 3. Max. Resolution: 500lp/mm with 2x objective & 10x eyepiece.
- 4. 2x objective having working distance of minimum 35 mm.
- 5. High object field diameter of 3.5 cm or better at min. zoom step of 0.61 with 1x objective & 10x eyepiece.
- 6. Microscope should able to achieve unrestricted high resolution and high depth at the same time.
- 7. High depth of field of 11 mm or better.
- 8. Total working distance of more than 120 mm with 1x objective.
- 9. Incident light base with black & white stage plate, Approx. Dim. (LxWxH) 277mm x 200mm x 22 mm.
- 10. Coarse/fine focus drive with 300 mm or better column.
- 11. Binocular tube with viewing angle of 35 to 40 degree, eyepieces 10x/23 (x2) having adjustable diopters and suitable for eyeglasses wearers and non-eyeglass wearers.
- 12. Illumination: Spotlight illumination with 2-arm Gooseneck with at-least 300 mm length, with 2 Hi-Power LEDs, control panel with separate gooseneck.
- 13. Camera: High definition 10MP Colour CMOS camera with memory card slot for direct image acquisition. Camera should have provision to control through PC.
- 14. Software: Microscope and Digital Camera Configuration and Control all fully integrated System, Auto and Manual Exposure adjustments to allow optimized imaging. It should control the camera features gain, binning, gamma, region of interest, Automatic recording of experimental parameters for reference or reloading for subsequent experiments, Adjust contrast, brightness and gamma on every image, Intensity, length and area measurements.
- 15. Must come with laptop computer for image recording (specifications RAM 8 GB; hard disc 1 TB; Processor i7; screen size not more than 14 inches; preloaded window).
- 16. Camera, Software and Microscope should be from same manufacturer.

You are therefore requested to please send your offer in two bid system indicating the maximum discount offered, installation charges along with a copy of authorization certificate, issued by the Principals/OEM. The quotations must accompany a Demand Draft amounting to ₹ 12,000/- (Rupees Twelve Thousand only), being the EMD in the name of Director, NIPGR, New Delhi and must be sent in a Sealed Envelope duly super-scribed on top of envelope as "Quotation for 01 no. of Stereozoom Microscope" so as to reach to the undersigned latest by 29/8/2017 (3:00 PM), the same shall be opened on same day at 3.30 PM.

नियम और शर्तै:

- 1. Every tender shall be accompanied with the tender cost of ₹ 500/- (Rupees Five Hundred only) in the form of Demand Draft drawn in favor of "Director, NIPGR" payable at New Delhi in separate sealed envelope along with the tender. In case the tender cost is not submitted, the tender will not be considered.
- 2. Every tender shall be accompanied with the required Earnest Money Deposit in the form of Demand Draft drawn in favour of the "**Director**, **NIPGR**" payable at New Delhi. Any tender not accompanied by such earnest money will be rejected straight away.
- 3. The rates quoted in the tender shall remain valid for a period 180 days from the date of issue of Award Letter. No tenderer can withdraw/or modify his tender or revoke the same within the said period. If a tenderer on his own withdraws or revokes the tender or revises or alters or modifies the tender for any item or condition within the period mentioned in the tender notice, his earnest money deposit shall stand forfeited. Notwithstanding foregoing, the Institute reserves the right to take other actions as deemed appropriate. In case the successful tenderer after award of acceptance of work fails to perform as per work order or violates any condition of tender, the security deposit/ performance security will be forefeited/encashed.
- 4. NIPGR does not bind itself to accept the lowest or any tender and reserves the right to reject any or all tenders without assigning any reason.
- 5. In two-bid system the tenders should be submitted containing (a) Technical Bid consisting of all technical details along with commercial terms and conditions and (b) Financial Bid indicating item wise price for the items mentioned in technical bid. The technical bid and financial bid should be sealed by the bidder in separate covers duly super scribed and both these covers must be put in a bigger cover which should also be sealed and duly super scribed. NIPGR will not pay any expense, whatsoever incurred by tenderer for the preparation and submission of tenders.
- 6. The notice inviting tender, will form part of the contract agreement to be executed by the successful tenderer with the NIPGR.
- 7. All the correspondence on the tender shall be addressed to the Director, NIPGR, Aruna Asaf Ali Marg, New Delhi and any communication addressed to anyone else shall not in any manner to be binding upon the NIPGR, Aruna Asaf Ali Marg, New Delhi.
- 8. The tenderer shall submit a copy of PAN/TIN/GST numbers allotted to them.
- 9. NIPGR reserves the right to change the quantities of the units while issuing the letter of award of work.
- 10. The successful tenderer shall be required to deposit an amount equal to 10% of the Tender value as Performance Security after adjusting the Earnest Money Deposit within 10 days from the date of issue of letter of acceptance.
