Name of Work:- Providing & Fixing shed over Condensing Unit of the Plant Growth Chambers and painting of Incinerator at NIPGR Campus New Delhi.

1. The contractor should visit the site and make them self-acquainted with the location of site. The Department shall not entertain any extra claim later on.
2. The site of work is at NIPGR Campus, Aruna Asaf Ali Marg New Delhi-110067.
3. The contractor shall make his own arrangement for the security of material at site.
4. The contractor shall arrange all T&P and nothing extra will be paid.
5. The contractor must get the prior approval of materials from the Engineer- In -Charge.
6. The rates shall be inclusive of Transportation, loading, unloading and handling charges of material.
7. Sample of all fittings and fixtures as per schedule of quantities, and specifications shall be submitted for preliminary inspection before procurement on large scale.
8. The contractor shall submit two copies of shop drawings for shed over Condensing Unit of Plant Growth Chambers for approval of the Engineer-in-charge before Fabrication of Shed.
9. After preliminary inspection, the sample should be fixed. Defects, etc. if any shall be rectified to the full satisfaction of the Institute / Engineer-in-charge.
10. Electricity shall be provided free of cost from Institute.
11. The rates shall be inclusive of all taxes including VAT etc.
12. The contractor shall follow all labour laws as prevailing in Delhi.
13. All works shall be completed to the entire satisfaction of the Engineer-in-charge.
14. The Institute reserves the right to reject / accept any or all quotation without assigning any reason.
15. The management also reserves the right to reduce / increase the scope of work as required.
16. In case of any dispute the decision of the Institute shall be final & binding on the contractor.
17. Any work not carried out as per instructions of the Engineer-in-charge shall be dismantled and reconstructed by the contractor without any extra cost.
18. Payment shall be made after completion of work.
19. The work shall be completed in all respects within **Six Weeks** from the date of issue of work order. Being a time bound, contract, and the contractor shall be liable to pay penalty @ 1% per day of work order amount, subject to maximum of 10% of work order amount if the work is not completed within stipulated time of Completion.
20. The Contractor shall be responsible for any damages and site clearance and nothing extra will be paid. In case the site clearance and damages are not attended, a recovery amounting to ₹.5,000/- (₹.Five thousand only) shall be made.

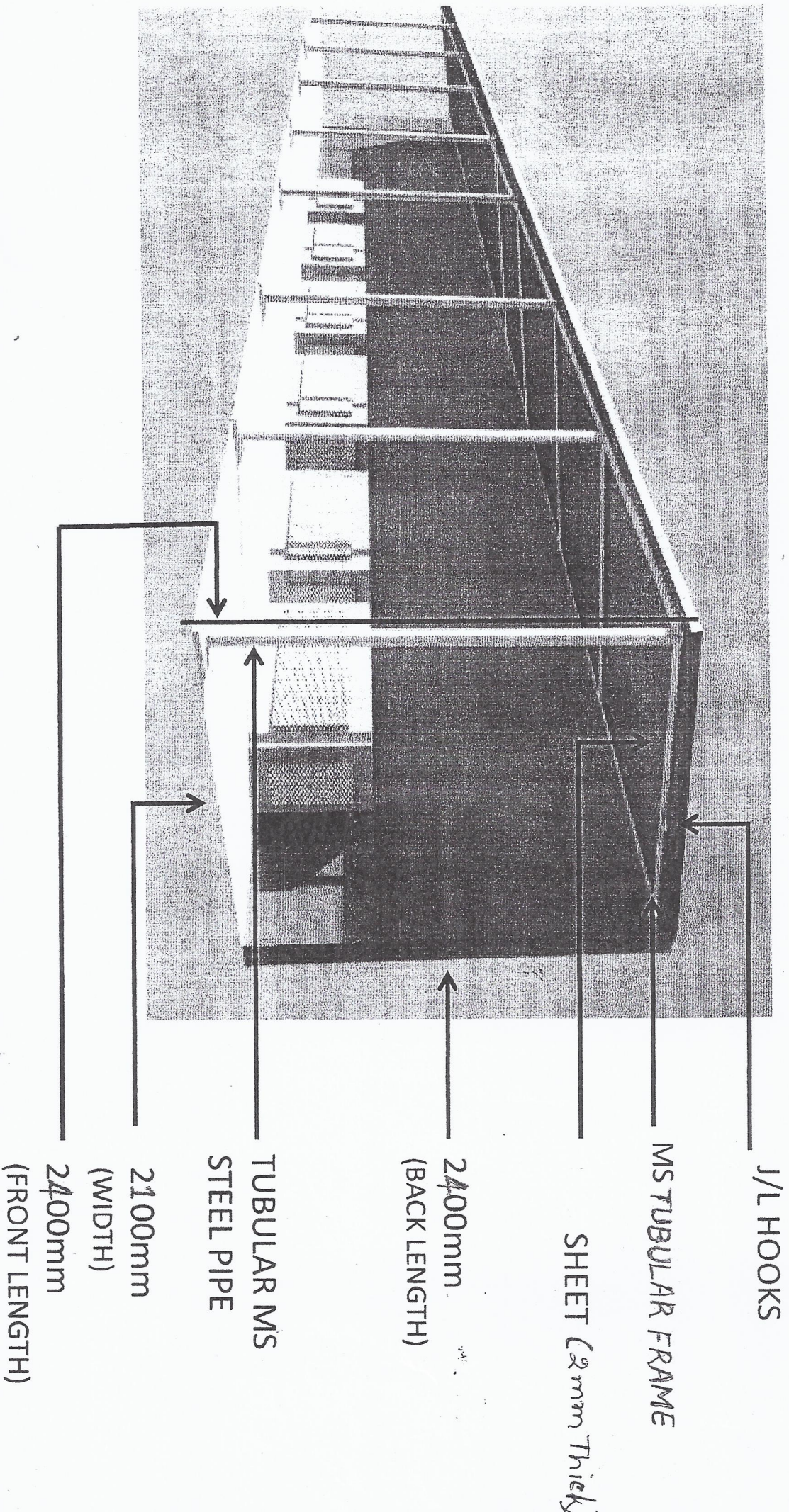

The agency shall have completed satisfactory one Civil work of similar nature i.e. Fabrication and Paintings in last three years ending 31st December 2014 with CPWD/PWD/Govt .Institutions or reputed organizations. Agency must submit the Completion certificate of One Work costing Rs.2.00 lacs. or more.
22. The quotation must be accompanied with EMD of ₹.4100.00 (₹.Four thousand & One Hundred only). The earnest money (EMD) shall be in the form of DD of scheduled bank drawn in favour of **"Director NIPGR" New Delhi. Without EMD, quotation will not be accepted.**
23. Security deposit @ 10% shall be deducted from the bill, the EMD shall however be adjusted against the Security Deposit.

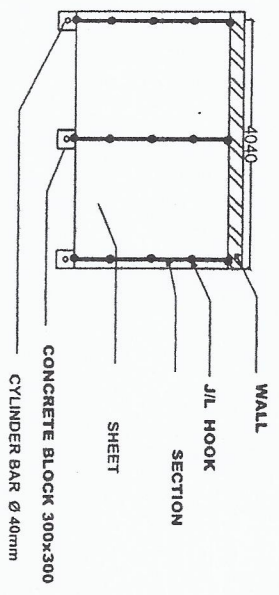
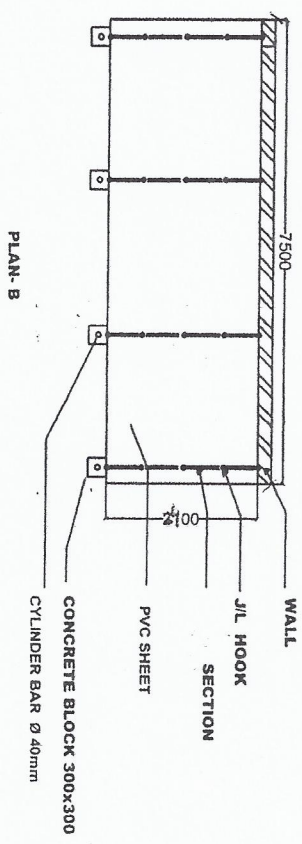
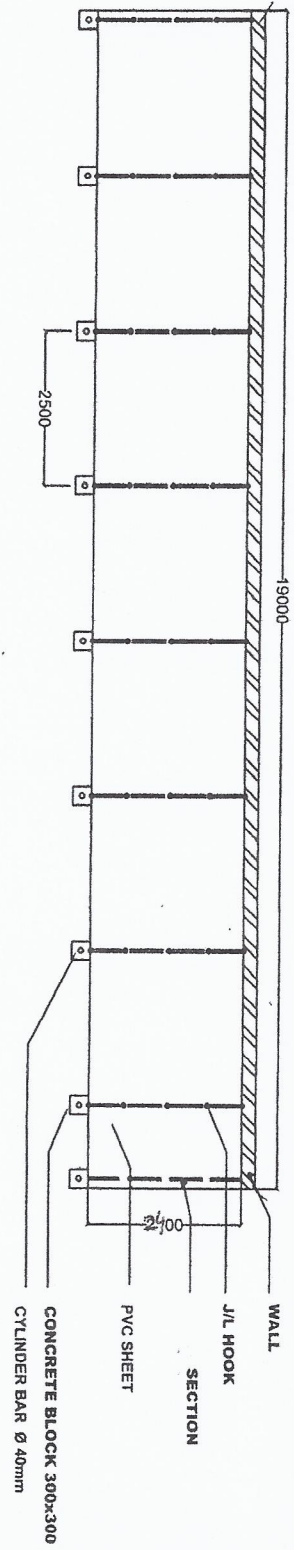
