Sealed Tenders are invited on behalf of Director, NIPGR from the Original Equipment Manufacturer or their authorized dealers for the purchase of 01 no. of -80°C Deep Freezer for the laboratory of our Institute, as per the following specifications in two bid system.

Technical Specifications

Freezer should be 500Litres to 600 litres of capacity with minimum, 400 Standard 2" Boxes (40000 Samples)

The freezer must be constructed using 1" thick vacuum panel insulation in conjunction with environmentallyfriendly water blown foam.

4 points Door gasket to ensure Maximum sample security.

Display should be Capacitive Touch Screen Input and Large 7 Inches Display with USB Data Retrieval

Freezer shall have adjustable power recovery time delay that allows user to set a time delay between 1 second and 20 minutes after power failure.

To reduce condensation, the perimeter heater shall be on the door side not on the cabinet size to limit heat introduction into the sample storage area

Freezer shall have an automatic heated pressure equalization port which allows for rapid re-entry to cabinet.

Freezer shall allow for set-point security control that blocks specific users from changing freezer set point or alarms through the use of a user name and password control. Unit shall allow creation for up to 150 users.

Inbuilt Power management system shall show incoming line voltage, indicate low or high line voltage, and provide voltage correction of up to +/- 10% of rating. Line voltage should be logged for a period of up to 15 years and be downloadable via a USB port.

Freezer shall record number of door openings and date/time of last opening. This counter shall be resettable by

Freezer shall use only natural, commercially available refrigerants (Hydrocarbon) with no special blends required.

Freezer must be built to and contain the registration mark for UL/cUL/CE/ISO standards for safety and performance.

Freezer Control sensor should be PT1000 (1000 ohm Platinum RTD) for accurate temperature controlling

Energy consumption should be 9.8 KW-Hr/Day or better in standard Mode of operation

You are therefore requested to please send your offer in two bid system indicating the maximum discount offered, installation charges along with a copy of authorization certificate, issued by the Principals/OEM. The prices and taxes should be quoted separately in the Price Bid. The quotations must accompany a Demand Draft amounting to ₹ 11,800/- (Rupees Eleven Thousand Eight Hundred only), being the EMD in the name of Director, NIPGR, New Delhi and must be sent in a Sealed Envelope duly super-scribed on top of envelope as "Quotation for 01 no. of -80°C Deep Freezer" so as to reach to the undersigned latest by 03/4/2018 (3:00 PM), the same shall be opened on same day at 3.30 PM.

- The tender document can be obtained from our Office on payment of ₹ 500/- (Rupees Five Hundred only) from 14/3/2018 to 02/4/2018 (01:00 P.M.). The tender document is also available on https://eprocure.gov.in and can also be downloaded free of cost from our website www.nipgr.ac.in.
- Every tender shall be accompanied with the required Earnest Money Deposit in the form of Demand Draft drawn in favour of the "Director, NIPGR" payable at New Delhi. Any tender not accompanied by such earnest money will be rejected straight away.
- 3. The rates quoted in the tender shall remain valid for a period 180 days from the date of issue of Award Letter. No tenderer can withdraw/or modify his tender or revoke the same within the said period. If a tenderer on his own withdraws or revokes the tender or revises or alters or modifies the tender for any item or condition within the period mentioned in the tender notice, his earnest money deposit shall stand forfeited. Notwithstanding foregoing, the Institute reserves the right to take other actions as deemed appropriate. In case the successful tenderer after award of acceptance of work fails to perform as per work order or violates any condition of tender, the security deposit/ performance security will be forefeited/encashed.
- NIPGR does not bind itself to accept the lowest or any tender and reserves the right to reject any or all tenders without assigning any reason.
- 5. In two-bid system the tenders should be submitted containing (a) Technical Bid consisting of all technical details along with commercial terms and conditions and (b) Financial Bid indicating item wise price for the items mentioned in technical bid. The technical bid and financial bid should be sealed by the bidder in separate covers duly super scribed and both these covers must be put in a bigger cover which should also be sealed and duly super scribed. NIPGR will not pay any expense, whatsoever incurred by tenderer for the preparation and submission of tenders.
- 6. The notice inviting tender, will form part of the contract agreement to be executed by the successful tenderer with the NIPGR.
- All the correspondence on the tender shall be addressed to the Director, NIPGR, Aruna Asaf Ali Marg, New Delhi
 and any communication addressed to anyone else shall not in any manner to be binding upon the NIPGR, Aruna

- 8. The tenderer shall submit a copy of PAN/TIN/GST numbers allotted to them.
- 9. NIPGR reserves the right to change the quantities of the units while issuing the letter of award of work.
- 10. The successful tenderer shall be required to deposit an amount equal to 10% of the Tender value as Performance Security after adjusting the Earnest Money Deposit within 10 days from the date of issue of letter of acceptance. Performance Security may be deposited in the form of Demand Draft or Bank Guarantee from State Bank of India Or any Scheduled bank which shall be valid till completion of the warranty period of quoted / ordered items. Incase of violation of any condition of Tender, the Security Deposit / BG will be forfeited / revoked.
- 11. The rates shall be inclusive of Transportation, loading, unloading, taxes etc., nothing extra will be paid.
- 12. The supplier should be responsible for any damage and site clearance and nothing extra shall be paid.
