
- 1. The contractor should visit the site and make them self-acquainted with the location of site. The Department shall not entertain any extra claim later on.
- 2. The site of work is at NIPGR Campus, Aruna Asaf Ali Marg New Delhi-110067.
- 3. The contractor shall make his own arrangement for the security of material at site.
- 4. The contractor shall arrange all T&P and nothing extra will be paid.
- 5. The contractor must get the prior approval of materials from the Engineer- In -Charge.
- 6. The rates shall be inclusive of Transportation, loading, unloading and handling charges of material.
- 7. The rates will be for finished items inclusive of the cost of material & Labour complete.
- 8. Electricity, if required shall provide by the Institute @Rs.10.00per Unit. The energy meter & electric cable/wire shall be arranged by the Agency.
- 9. The rates shall be inclusive of all taxes including VAT & Service tax.
- 10. The contractor shall follow all labour laws as prevailing in Delhi.
- 11. All works shall be completed to the entire satisfaction of the Engineer-in-charge.
- 12. The Institute also reserves the right to reduce / increase the scope of work to a maximum of 50%.
- 13. The Institute reserves the right to reject / accept any or all quotation without assigning any reason.
- 14. In case of any dispute the decision of the Institute shall be final & binding on the contractor.
- 15. Any work not carried out as per instructions of the Engineer-in-charge shall be dismantled and re-constructed by the contractor without any extra cost.
- 16. Contractor shall have experience in the field of civil work of MS fencing work.
- 17. The work shall be completed in all respects within **Six weeks** after issue of issue of work order. Being a time bound contract, and the contractor shall be liable to pay compensation @1.0% per day subject to maximum of 10% of work order amount if the work is not completed within stipulated time of Completion.
- 18. The Contractor shall be responsible for any damages and site clearance and nothing extra will be paid. In case the site clearance and damages are not attended, a recovery amounting to Rs. 10,000/- (Rs. Ten thousand only) shall be made.
- 19. Payment shall be made after completion of work., after deduction of tax at source as per rule.

- 20. The quotation must be accompanied with EMD of Rs. 8130.00(Rs. Eight Thousand & One hundred & thirty only) EMD shall be in the form of DD of scheduled bank drawn in favour of "Director NIPGR" New Delhi. Without EMD quotation shall not be considered.

- 25. All papers attached with this Quotation should be signed & returned in original.


