Sealed Tenders are invited on behalf of Director, NIPGR from the Original Equipment Manufacturer or their authorized dealers for the purchase of 01 no. of Protein Electrophoresis with Western Blot Module for the laboratory of our Institute, as per the following specifications:.

Technical Specifications

Large format vertical electrophoresis requirements for casting 16 x 16 cm gel size that should includes four 1.5 mm spacers, two 15well combs, 2 sets of glass plates, 2 sets of sandwich clamps, casting stand, upper buffer dam, alignment card with leveling bubble etc.

Should accommodate hand cast 16 x 16 cm gels

- System should include casting stand that exert uniform pressure along the entire length of the glass plates that provide a leakproof seal without agarose plugs or grease
- Should include central cooling core that can be connected to tap water or a cooled recirculating bath, or filled with coolant, providing smile-free patterns with as little as 1.5 L of buffer
- Should have choice of glass plates, spacers, and sandwich clamps to cast 2 gel lengths, 16 or 20 cm; inner plate dimension should be 20 x 16 cm and outer plate dimension should 20 x 18.3 cm having 18.3 cm spacer
- System should have ability to cast multiple gradient gels using the multi-gel casting chamber and should have the gel clip that facilitates
- System should be capable of running up to four 16 x 16 cm or 16 x 20 cm handcast gels to be run simultaneously

If necessary system can be used for high-resolution vertical agarose electrophoresis of nucleic acids

It should allow simple comb removal

System should allow easy conversion to applications such as tube gel IEF and second-dimension SDS-PAGE16 x 16 cm gel size that should includes four 1.5 mm spacers, two 15-well combs, 2 sets of glass plates, 2 sets of sandwich clamps, casting stand, upper buffer dam, alignment card with leveling bubble etc.

With suitable power pack and UPS

1. Should be convenient - for simultaneously transfer up to four mini-sized gels or two midi sized gels. Designed for rapid semi-dry transfer of proteins from polyacrylamide gels to nitrocellulose or PVDF membranes in 5-10 minutes

2. Should have integrated power supply with blotting Software and the blot Cassette (for blotting)

3. Preprogrammed methods for Low MW, Mixed Range MW, High MW, Standard Semi Dry, 1.5 mm gels or unknown size gels

USB port should be there for program transfer

5. Easy-touch programming for access to pre-programmed transfer methods based on the gel number, gel size and molecular weight range of proteins using color LCD menu touch screen and also to easily create, run and save custom transfer methods 6.

Should have Audible alarm for No-load detection, No cassette detection, End of run

- Should be CE / TUV certified
- 8. Should be able to store 20 or more programmable methods.

System should have Cooling fan

- 10. Should be an open system which accepts accessories and consumables from different suppliers also
- Should be Upgrade-ready for fast Coomassie dye staining & destaining of protein gels in 6-11 minutes

नियम और शर्तैं:

- 1. Every tender shall be accompanied with the tender cost of ₹ 500/- (Rupees Five Hundred only) in the form of Demand Draft drawn in favor of "Director, NIPGR" payable at New Delhi in separate sealed envelope along with the tender. In case the tender cost is not submitted, the tender will not be considered.
- 2. Every tender shall be accompanied with the required Earnest Money Deposit in the form of Demand Draft drawn in favour of the "Director, NIPGR" payable at New Delhi. Any tender not accompanied by such earnest money will be rejected straight away.
- 3. The rates quoted in the tender shall remain valid for a period 180 days. No tenderer can withdraw/or modify his tender or revoke the same within the said period.
