3. Any kind of accident/electrocution caused due to negligence or during the course of normal work etc. shall be the responsibility of suppliers / contractor. The contractor shall be responsible for all compensation to the staff engaged by him.
4. NIPGR does not bind itself to accept the lowest or any tender and reserves the right to reject any or all tenders without assigning any reason.
5. NIPGR will not pay any expense, whatsoever incurred by tenderer for the preparation and submission of tenders.
6. The notice inviting tender, will form part of the contract agreement to be executed by the successful tenderer with the NIPGR.
7. All the correspondence on the tender shall be addressed to the Director, NIPGR, Aruna Asaf Ali Marg, New Delhi and any communication addressed to anyone else shall not in any manner to be binding upon the NIPGR, Aruna Asaf Ali Marg, New Delhi.
8. The tenderer shall submit a copy of PAN/TIN numbers allotted to them.
9. NIPGR reserves the right to change the quantities of the units while issuing the letter of award of work.
10. The contract is initially for twelve months, which can be extended or curtailed at the discretion of the Institute and on satisfactory performance.

The successful tenderer shall be required to deposit an amount equal to 10% of the Tender value as Performance Security after adjusting the Earnest Money Deposit within 10 days from the date of issue of award letter. Performance Security may be deposited in the form of Demand Draft or Bank Guarantee from State Bank of India Or any Scheduled bank. In case of violation of any condition of Tender, the Security Deposit will be forfeited.
12. The payment shall be released upon completion of the service contract and no advance shall be paid.
