This has reference to our tender no. 13(A&B)/2024-25/NIPGR/S&P published vide Central Public Procurement Portal (CPPP) vide ID No. 2024_NIPGR_833250_2 dated 30/10/2024 on the above-mentioned subject.

In this context, the following changes may please be noted for compliance:

The list of items provided at Annexure IV and V with the Technical Bid may be treated as illustrative and not exhaustive. Further, the Financial Bid to the Tender Document may be ignored.

Further, the following points are added to the tender document towards Financial Bid:

Terms and Conditions for Tender Prices (Financial Bid)

- 1. Discounts (including Special discount, if any) applicable on the Price List/Price offer shall be mentioned clearly in terms of percentage by the manufactures/authorized suppliers.
- 2. Maximum discount for the entire catalogue prices shall make the bid more responsive among the eligible tenderers.
- 3. Conditional discount offer by the bidder shall not be considered at the time of evaluation.
- 4. Prices quoted by the tenderer shall remain fixed during the entire period of contract and shall not be subject to variation on any account. A bid submitted with an adjustable price quotation will be treated as non-responsive and rejected. Accordingly, quality manufacturers or their authorized distributors/dealers may furnish their Price offer or Price List with maximum discount to supply these items. The Price List with maximum discount thereon must be signed by the authorized signatory of the principal supplier with official seal along with softcopy in excel sheet. Please note that if the price list is not provided in Excel Sheet, the bid is liable to be rejected. It may also be noted that the price list provided in Excel Sheet must be in conformity with the items and prices provided in the catalogue, failing which appropriate action as deemed fit shall be initiated by the Institute.
- 5. Any request for increase in prices will not be entertained for during rate contract period.
- 6. The price of the goods offered in the bid should be inclusive of all charges.
- 7. Prices charged for the stores supplied under Annual Contract should in no case be higher than the lowest prices at which the party sells the items of identical description to any other Govt. organization or any such organization in India during the period of contract, failing which the "FALL CLAUSE" of tender will be applicable. A certificate to this effect may be provided by the Tenderer in Annexure-VI.

In addition to above, the closing date of submission of bid has been extended to November 29, 2024.

All other terms and conditions of the tender remain unchanged.

In such case the NIPGR may impose penalty to remove us from Rate Contract.
