A branded NAS storage system; 2U rack unit; minimum 12 hot swap bays with at least 4 x 3 TB SATA disks; RAID levels 0, 1, 5, 6 and 10; should have automatic volume expansion, thin provisioning, web-based management interface, global hot spare support, data protection using unlimited snapshot and web based monitoring for capacity/performance/resource utilization; file sharing protocol AFP 3.3, NFS v3, HTTP, WebDAV, CIFS/SMB 3, MS AD support authentication; at least 4 gigabit LAN ports with support for Link Aggregation; minimum two USB 3.0 ports; redundant power supplies; 3 years plus additional 2 year warranty — OEM MAF is required as prequalification

One branded 6KVA online UPS (should be rack/tower mountable) with inbuilt battery backup with minimum 15 mins; LCD display; >93% efficiency in on-line mode; should have capability to add external battery module for increasing runtime; atleast 7 – 10AMP IEC sockets and 2 – 15AMP IEC sockets, options to add external batteries, MC Certifications: IEC/EN 62040 -2, FCC Class, IEC/EN 62040-3 with 2 years warranty

Scope of Work: Integration of the NAS storage with existing computing facility; integration of various bioinformatics (genome/NGS data analysis) softwares/applications as per requirement time-to-time; enabling the sharing among the windows and Linux cluster for user home directories; mapping of volumes for genome sequences analysis and blast sequences

नियम और शर्तैं:

- 1. Every tender shall be accompanied with the tender cost of ₹ 500/- (Rupees Five Hundred only) in the form of Demand Draft drawn in favor of "Director, NIPGR" payable at New Delhi in separate sealed envelope along with the tender. In case the tender cost is not submitted, the tender will not be considered.
- 2. Every tender shall be accompanied with the required Earnest Money Deposit in the form of Demand Draft drawn in favour of the "Director, NIPGR" payable at New Delhi. Any tender not accompanied by such earnest money will be rejected straight away.
- 3. The rates quoted in the tender shall remain valid for a period 180 days. No tenderer can withdraw/or modify his tender or revoke the same within the said period. If a tenderer on his own withdraws or revokes the tender or revises or alters or modifies the tender for any item or condition within the period mentioned in the tender notice, his earnest money deposit shall stand forfeited.
