INSTRUCTION

- a) Hostel subsidy can be availed of for a maximum of 2 children
- b) Reimbursement as indicated above will be applicable for expenditure on the education of school going children only i.e. for children from classes nursery to twelfth, including classes eleventh and twelfth held by junior colleges or schools affiliated to Universities or Boards of Education.
- c) Hostel subsidy shall have no nexus with the performance of the child in his class. In other words, even if a child fails in a particular class, the Hostel subsidy shall not be stopped
- d) Hostel subsidy will be reimbursed upto the maximum limit of Rs.3,000/- per month per child subject of maximum of 2 children. However, both hostel subsidy and Children Education Allowance **cannot** be availed concurrently
- e) In case both the spouses are government servants, only one of them can avail reimbursement against hostel subsidy.
- f) Children attending day-boarding, whether attached to schools or not are not eligible to draw hostel subsidy.
