### INSTRUCTIONS

- The selected candidates are advised to deposit an amount of ₹5,000/- (Academic Administration Fee) by online mode ([RTGS details attached](#)) by **July 13, 2026 (by 05:30 p.m.)**, failing which the offer of admission shall stand cancelled and the seat will be offered to the next candidate in the waiting list. **The candidates are further required to submit the transaction details (Email: [nipgr@nipgr.ac.in](mailto:nipgr@nipgr.ac.in)) by July 13, 2026 (by 05:30 p.m.)**.

The Academic Administration fee of ₹5,000/- per student per semester (Two semester per Academic Year) must be deposited by the candidates within one month of the start of each semester (July (Monsoon) & January (Autumn)) until the viva voce examination.

- The admission shall be considered provisional till production of all original certificates in support of the educational qualifications including M. Sc. pass certificate, category certificate, valid fellowship certificate, migration certificate, in original, along with an attested copy, for verification.
- If the verification reveals that the claim of the candidate seeking reservation under SC/ST/OBC/PWD/EWS category (**Certificates issued by the Union/Central**

**Government / appropriate authority will be considered for admission against the reserved seats)** is false, the admission shall be terminated forthwith without assigning any further reasons.

- **The candidates seeking reservation under OBC category are further advised to bring a certificate from a Competent Authority (SDM/Employer of the parents) regarding not belonging to 'Creamy Layer' of OBC together with a duly authenticated salary certificate of Father & Mother (if employed) indicating the annual total salary for past three years.**
- The admission is based on the information given by the candidate in his/her application and shall be considered null and void if a material error/suppression is discovered at any time.
- Reservation of seats for admission for reserved category has been followed as per norms.
- In cases where result of the final year examination of M. Sc. is still awaited, the qualifying mark-sheet/certificate thereof is required to be produced to the Institute by August 31, 2026. If there is further delay in declaration of result, prior written permission of BRIC-NIPGR to produce the certificates beyond the prescribed date, may be sought.
